4. Payment according to the payment plan(s) has to be made by cheque/demand draft/banker's cheque/cash separately for each application.
5. Cheques must be drawn on any scheduled bank, which is member of banker's clearing house located at the place where Application form is to be submitted.
6. cheque's , Demand Draft must be drawn in favour of Om Shivay Bizcon Pvt. Ltd. and crossed A/c Payee only.
7. Customer should mention Application form no., Name and complete Address on reverse side of the instrument of payment.
